BIA Addresses Whistleblowing as a Basis for Asylum.

In *Matter of N--*, 25 I&N Dec. 526 (BIA 2011) the BIA found that retaliation for opposition to state corruption may form the basis for a claim based on political opinion if, post-REAL ID, the actual or imputed anti-corruption belief was one central reason for the harm.

BIA Remands for Further Fact Finding in Domestic Violence Asylum Case.

In an unpublished decision, the BIA, remanded for entry of a new decision, calling for further factual development and arguments specific to the gender-based asylum claim relating to domestic violence, consistent with the Attorney General's directive in *Matter of R-A-*.

BIA Finds that Washington Statute Relating to Driving and Attempting to Elude Police Vehicle is a Crime Involving Moral Turpitude.

The BIA held in the *Matter of Ruiz-Lopez*, 25 I&N Dec. (BIA June 30, 2011) that the offense of driving a vehicle in a manner indicating a wanton or willful disregard for the lives or property of others while attempting to elude a pursuing police vehicle in violation of section 46.61.024 of the Revised Code of Washington is a crime involving moral turpitude.



BIA Sets Forth Framework for Firm Resettlement Findings.

The BIA, in *Matter of A-G-G*, 25 I&N Dec. 486 (BIA 2011) set forth a framework for firm resettlement determinations (in asylum cases), focusing exclusively on the existence of an offer of permanent resettlement, and allowing for the consideration of direct and indirect evidence.
