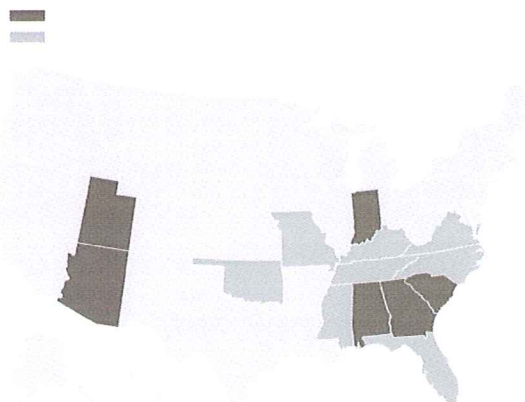
Anti-Illegal Immigration Laws in States.

On Wednesday, April 25, the Supreme Court heard oral arguments in a case challenging Arizona's immigration enforcement law. Since Arizona enacted the law in 2010, 13 other states have either passed or debated similar legislation.

State Passed Current status

Arizona April 2010

The federal district and appeals courts temporarily blocked the provisions from going into effect. Arizona appealed those decisions.

Utah March 2011

A district court judge granted a temporary injunction against the measure two months later and extended the order in February, pending the Supreme Court ruling.

Georgia April 2011

A federal judge blocked key provisions of the law and the state has appealed. Appeals court judges are awaiting the Supreme Court decision.

Indiana May 2011

A district court judge put a temporary hold on the law's police enforcement provisions.

Alabama June 2011

A federal court put a temporary hold on some of the law's controversial provisions, but an Alabama district judge allowed some others to go into effect. South Carolina

June 2011

A federal judge blocked the most controversial aspects of the law before it took effect in January.
